# **Nursing and the Cochrane Database**

It is useful to be aware of the use of the Cochrane Database in relation to nursing research. Systematic reviews gather studies, including randomized controlled trials, concerning a topic.

Although we often think of Cochrane as a source of systematic reviews in medicine, it also covers topics in nursing.

The Cochrane database is divided into 11 fields by subject. One of these is the Nursing Care Field. Its purpose is to encourage evidence based nursing research. It is coordinated from the Joanna Briggs Institute at the University of Adelaide, Australia.

The Joanna Briggs Institute has members from all over the world interested in promoting nursing research. In 2006 it began discussing forming a nursing research field in Cochrane. After several years of formation, it was formalized under its current name in 2010. Participants come from over 35 countries.

An interesting study was published by Mistiaen, et al, which looked at the usefulness of the Cochrane Database in nursing research at that time and found that nursing interventions were investigated in addition to medical issues.<sup>1</sup> The study pointed out that Cochrane can be useful for several reasons to nurse researchers:

- It gathers studies that show whether an intervention has had a positive or negative effect on patient care.
- It can conclude that there is insufficient evidence of either positive or negative effect.
- It can show that a particular issue needs to be researched more thoroughly, showing a potential researcher that this topic might be fruitful for them to pursue.

I did a more recent, less scientific search of the Cochrane database under "nursing." It showed a number of recent reviews of nursing interventions. This shows that the Cochrane Database of Systematic Reviews can be a useful source in nursing research.


# **Monmouth Medical Center Anniversary**

# NN/LM Mid-Atlantic Region Update

One of the many exciting roles of a regional medical library is exhibiting at national, regional, state and local meetings and conferences. Exhibiting offers the opportunity to demonstrate NLM products to health professionals, consumer groups and public, school and health sciences librarians. It is also a great way to promote membership and services of the National Network of Libraries of Medicine. In our first year as a regional medical library, NN/LM MAR staff promoted NLM resources to over 1,000 health professionals, public health workers, community-based leaders and librarians through exhibiting at 4 national and 8 regional or state meetings. Staff also reached a large population of health consumers during a local employee health fair. For instance, staff highlighted drug information resources to pharmacists during the American College of Clinical Pharmacy annual meeting; emergency response tools and public health resources during the NJ Environmental Health Association meeting and K-12 resources to school librarians at the New York City School Library Association annual conference.

MAR also offered <u>exhibit awards</u> to allow Network members the opportunity to exhibit at a state or local level. Drexel University public health librarians attended and exhibited during the Pennsylvania Public Health meeting held in Philadelphia, PA; whereas, Mid-Atlantic Behavioral Health received an award to exhibit and present mental health services and resources to area seniors in Newark, DE.

The regional medical library 2012-2013 contract year began on May 1. So far, MAR has exhibited at the following national, regional and state meetings:

- Delaware/Maryland Joint Library Association
- New Jersey Library Association
- Pennsylvania Mental Health Consumers Association

Information professionals located in public libraries, community colleges and institutions offering 2-year and 4-year academic programs in the health sciences will be able to stop by the MAR exhibit booth at the upcoming NY and PA state library association meetings. Those in K-12 libraries and science teachers will benefit from MAR exhibits during the NJ Association of School Librarians, NY City School Library System and the NJ Science Convention meetings.

Outreach to public health workers and unaffiliated health professionals will occur through exhibiting at the Migrant and Immigrant Health in Rural Pennsylvania Conference, as well as 3 state public health association meetings: New York Public Health Association, Pennsylvania Public Health Association and New Jersey Public Health Symposium. And finally, MAR plans to exhibit to mental health professionals and consumers during the Delaware Community Mental Health



Conference, Delaware Psychological Association Mixer, Pennsylvania Mental Health Consumers and New Jersey Association of Mental Health and Addiction Agencies annual conferences.

Medical librarians support the information needs of their users in different nature either in academic or clinical base every day. Due to socio-economy situations, libraries (in general) also health sciences libraries have been facing many problems such as: justifying the need of library services; defending budget against proposed cuts; maintaining or expanding the staff, space or collections; and so forth. Meanwhile, the closure of a few hospital libraries both in NY & NJ has drawn our attention in the past couple of months. Not all of these closures were based on the library staff and the director decisions (case of the John Hopkins Medical library) but due to the administration!

What could be done? Is there anything that we as "librarian", could do to avoid situation of such? How could we keep the library visibility high among the administrators? Is there any effective way to communicate with the administrators and the users? Is there a systematic method to follow? 
